We the undersigned natural persons of the age of twenty-one (21) years or more, at least two of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE ONE

The name of the corporation is FREDERICKSBURG UNITED METHODIST CHURCH FOUNDATION, INC.

ARTICLE TWO

The corporation is a non-profit corporation and has no capital stock.

ARTICLE THREE

The period of its duration is perpetual.

ARTICLE FOUR

The purposes for which the Corporation is organized are:

To propagate and proclaim the Christian faith.

To extend and fulfill the mission and ministry of the Fredericksburg United Methodist Church and/or the United Methodist Church in accordance with the discipline, doctrine, worship and service of the United Methodist Church.

To receive gifts, grants, devices, and bequests of any nature

whatsoever, whether real or personal for the use and benefit of the  
Fredericksburg United Methodist Church and/or the United Methodist  
Church.

To have full power to do any and all things necessary and  
desirable for the prudent management of this Corporation with a view  
toward achieving its purposes.

These purposes herein enumerated shall not be limitations upon  
the powers of said non-profit corporation, but shall be a general  
statement of purposes.

ARTICLE FIVE

The street address of the initial registered office of the  
Corporation is 1800 North Llano, Fredericksburg, Gillespie County,  
Texas, and the name of its initial registered agent at such address is  
Reverend Rick Waters.

ARTICLE EIGHT


The members of the Corporation shall be all active members of Fredericksburg United Methodist Church
